137/15 Planning information received since the last Meeting:

Members were reminded that the Hearing date for the Picton House appeal is Tuesday 21st July at 10 am at the County Council Offices at Spillman Street, Carmarthen. Councillors T Paradice, D Howells and W M Tucker were interested in attending.

8 Training:

The Clerk recommended that every Councillor would benefit from this very important and interesting course. The next course is on Tuesday 9th June at 6 pm. Cllrs T Paradice, D A Howells and M J Fear agreed to attend.

9 Events:

139/15 Local and National Events:

- (a) Tuesday 26 May Cllr W M Tucker attended the Town and Community Council Forum and reported that the Llanddowror Flood Plan was used as a case study upon which CCC's Civil Contingencies plan was based. The lack of affordable housing was also discussed.
- (b) A Service was held at St Teilo's Church Llanddowror on Friday 29th May when the new Chairman Cllr A J Paradice and new Vice Chairman Cllr G H James were inducted. This was followed by an enjoyable Buffet in the Community Meeting Room.

- (c) Saturday 20th June 12 noon 4.30 pm 'Blue Eliffant Picnic in the Park'. An Invitation to attend a Welcome Reception at 11.30 am has been extended to our Chairman Cllr T Paradice and Mrs Paradice
- (d) Monday 15th June A Meeting with CCC's Executive Board to address issues arising in both Llanmiloe and Llanddowror was expected to be held.
- (e) Thursday 18th June Flood Warden's Meeting at 7 pm in the Meeting Room. It is hoped that an Official from CCC will be able to attend in order to answer questions on flooding and Old Trunk Road/Tavernspite road issues which had been posed by residents. Cllr Tucker and the Clerk would attend. Apologies received from Cllr T Paradice.
- (f) Wednesday 24th June Cllr T Paradice stated that he would attend the Joint Council meeting at 7.15 pm in Llangynin.
- (g) Tuesday 30th June Carmarthenshire Area Committee (One Voice Wales) meeting at 7 pm at the Princess Gwenllian Centre, Kidwelly. Cllrs J S Hewens and W M Tucker agreed to attend.

10 Administration:

- 140/15 Co-option of Councillor for the North Ward: Two applications were received for this position but one had declined so this evening's interview was for one candidate only and it was Resolved that Mrs A Crewes be co-opted on to the Council.
- 141/15 Revised Guidance on Code of Conduct this has been issued by the Ombudsman and Members have been given details of the website for downloading the document.
- 142/15 Statutory Guidance on Access to Information Members were given details.
- 143/15 <u>Public Conveniences, Llanddowror</u>: It has been necessary to purchase toilet rolls for the PCS. Clerk requests a further order for cleaning materials as and when necessary. The PCs continue to be cleaned by volunteers from Llanddowror.
- 144/15 <u>Meeting Room Update</u>:

A meeting of the Working Party was held on Friday 15th May. Issues discussed were: the accumulation of rainwater on the forecourt, the removal of tree stumps, cleaning up around the Meeting Room, PCs Rota for cleaning, Opening and closing the MR for events and caretaking duties. It was agreed that the builder be contacted regarding the forecourt and tree stumps. Further volunteers were available to clean the PCs. Members of the MR Working Party scheduled a day to clean up around the premises.

- 145/15 <u>Grass Cutting/Maintenance of the Verge in Llanmiloe</u>: R Jones has commenced cutting the grass to a satisfactory standard.
- **Matters arising:** It had been resolved to bring up the following matters at the meeting with Executive Board on Monday 15th June but it is now uncertain whether the meeting will go ahead:

146/15 Llanmiloe:

- (a) Pruning of Trees
- (b) Clearing of Drain with new cover
- (c) Loose guttering on 'bus shelter
- (d) Emptying of dog waste bins
- (e) Dog Fouling Signs: to be positioned adjacent to playing fields.
- (f) Condition of the road and Cats eyes missing between Brook and Pendine
- (g) Tree near the bus shelter needs urgent pruning (Westmead Close)
- (h) Issues with the A-road in Llanmiloe being repaired rather than being re-surfaced.

147.15 Llanddowror:

- (a) Old Trunk Road (C3236) and Tavernspite Road (C3230)
- (b) Request for Mobile Speed Camera on Old Trunk Road C3236 together with solar-powered 'flashing' speed indicator
- (c) Directional Signs the new Llanddowror road junction (off the A477 Trunk Road and C3236) is in complete darkness during winter months and illuminated signage would be advantageous.

148.15 Other Issues:

- (a) <u>Flooding</u> a request had been received from Llanddowror residents that CCC reconsider their rateable values for Community Charge.
- (b) <u>Development at Old Mill, Llanddowror</u>:
 - (i) Planning, highway accesses and noise issues. CCC has been contacted regarding an update on this issue. CCC advised that a further visit is to be made.
 - (ii) Changes to the Watercourse An Officer from CCC has again visited the site and forwarded a Report, together with a Flood Map and photograph, for Members' information. CCC has been invited to attend the Flood Warden's Meeting on Thursday 18th June.
- (c) <u>Footpath between Pen-y-Graig and Y Bont</u>: needs attention more details required prior to CCC Footpaths being approached. It appears that CCC will be sending to Community Councils details of footpaths in their area.
- (d) Loose Cable near Pedestrian Bridge: pending
- (e) <u>Llanmiloe Post Office Opening Times</u>: No reply as yet to the letter sent to the Postmistress but it was reported that a new Postmistress has been appointed.
- (f) It was reported that stones/debris had been removed from Brook and part of the road has been tarmacked.
